<u>Note</u>: The Folder 1 list is somewhat in order of the relationship to our parents. Folder 2/3 lists are mostly by date, as are the items in the folders. Some are copies as I do not have the originals. Also I know less about these documents than about those I sent in April 2012. (*didn't survive.)

- 2. Berta/Bertha (nee Goldstein) and Minna Stiefel are Sally's mother and sister who emigrated with him in March 1939.

- 4. Joseph Wasserman is husband of Sally's sister Paula. Affidavit for Berta, Sally, Minna, April 1938.

- 6. *Selma Stiefel Lorch/Lorsch is sister of Sally. 4/22/1940 affidavit of support for her family signed by *Norman S. Stiefel*
- 7. *Gustav Stiefel is brother of Sally. Unsigned, undated affidavit of support by *Norman S. Stiefel*.
 Also typed unsigned support letter 9/16/1940.



- 8. Emil Stiefel is brother of Sally. 1/28/1940 letter. Feb 1941 letter and env (with date of reply); also has notes by Irma and Paula.
- 9. Adolf/Adolph Stiefel is brother of Sally (his wife is Irma Salomon, a first cousin as their mothers Bertha and Rechina Goldstein were siblings)
- 10. Erwin Stiefel is Ruth's brother. 3/18/1940 affidavit for Hausmann's and Steinberg.
- 11. Malke Stiefel Hausmann (Manya is name we knew) is sister of Ruth's father Josef Stiefel.
- 12. Sophie Stiefel Traun is a first cousin of Ruth's father Josef Stiefel (both are grandchildren of Samuel Stiefel who was born 1806 in Vienna, died 1890 in Sieniawa). Her husband is Semi Traun. 8/6/1938 affidavit for Ruth 2 sheets.
- 13. Sidney Magazine is accountant for Sally. 12/10, 1940 letter re Adolf Stiefel.
- 14. Louis Comonow and Milton Feld are acquaintances of Sally in Kansas City. Comonow affidavit and sample 1941 letters mention Gustav Stiefel family. Feld affidavits mention Karl Steinberg (unknown) and Hausmann's.
